2. Approve XWG minutes from 4/26

- A motion to approved the minutes from 26 April was made by: Divya Kolar (Intel). The motion was seconded by Mike Aguilar (Sandia). The minutes were unanimously approved.

3. Officer Nomination and Voting Timeline & Process

- Officers are elected to two year terms.
 - Chair and Secretary elected in even numbered years.
 - Vice Chair and Treasurer elected in odd numbered years.
 - Thereafter, officers serve a 2 year sentence.
- Officer candidates must be employees/contractors of promoters
 - Need not necessarily be a Director from that company/organization.
- Participation in nominating and voting is limited to promoters.
- Each promoter gets one vote (per position).
- Elections held at the June Board meeting.
- Nominations close at the end of the May Board meeting.

4. Director Quorum and Attendance discussion / Bylaws

- We would like to define in the Bylaws in regards to Director attendance at meetings and a minimum requirement for a voting quorum :
 - Participation requirements.
 - What happens if participation requirements are not met?
 - How to correct a non-participation issue.

5. Collaboration Status (regular updates, if any)

- We currently have a collaboration with SNIA. There is some interest in collaborations with Gen-Z and the IBTA. There is no information, yet, on interest for collaboration with UCX or the Linux Kernel Community.

6. The OpenFabrics Workshop, Post Mortem

- We are looking at reducing the costs by changing the Workshop location. The motivations include potentially increasing Workshop attendance and audience pool and make shortening the Workshop a requirement to save costs.
 - If we co-locate our Workshop with another conference, co-location removes flexibility in Workshop location. However, co-location can allow our Workshop to benefit from co-promotion and have joint activities with similar technical programs. In addition, co-location can potentially expand our audience to include users, application developers that likely unaware of OpenFabrics.
 - Potential Events
 - Cloud Expo
 - Hot interconnects
 - Linux community events
 - NetDev
 - OCP Summit
 - Open Networking Summit
 - SNIA Events such as PM Summit or Storage Developers
 - Another option for reducing costs would be to change the Venue search. Recommended venues include:
 - Argonne
 - Sandia
 - Lawrence-Livermore
 - NCAR-Boulder
 - Oak Ridge
 - Universities
 - Indiana University
 - Ohio State University

- University of California-Berkeley
- University of Texas-Austin
- Intel Jones Farm Campus
- Shortening the program length to 3 days would help with costs, be less arduous on attendees, and allow for the Technical Program Committee to be more selective with session submissions.
